PHILOSOPHY

At Happy Valley Children's Ranch Preschool, we believe that children learn best through meaningful play experiences both inside the classroom and the outside environment. We provide an atmosphere that is safe, nurturing, respectful, creative and fun. We teach children about the importance of respecting themselves, others, animals and the environment. We help children develop social, emotional, physical and intellectual skills through age appropriate activities.

PROGRAM & CURRICULUM

Happy Valley Children's Ranch offers a preschool program for children ages 3 to 6 years old. Classes are in session from September through May. We offer morning and afternoon sessions. Morning sessions are 3 hours and afternoon sessions can be either 2.5 or 2.75 hours (Pre-k only). Children may attend two, three or four days per week. A unique part of the program at Happy Valley is our ranch type setting. During outside time (weather permitting) the children are offered rides on the ponies. They also enjoy interacting and learning about the other barn animals in our petting pen (sheep, rabbit, goats and pig). We use an integrated theme-based curriculum where we change themes every month. We also use the Second Step Curriculum to teach social and emotional skills and Learning without Tears "Get Set for School" curriculum to teach cognitive skills.

SCHOOL POLICIES AND ADMISSION

Families are to acknowledge that they have read the Family Handbook at time of enrollment. **In order to attend Happy Valley, children must be mastered in toileting and up to date with their immunizations as required by the Colorado Department of Health. No personal exemptions are accepted. We do accept medical exemptions signed by a Doctor.**

- General Information & Authorization Form (required no later than 30 days before attending school)
- General Health Appraisal Form (required no later than 30 days before attending school)
- Certificate of Immunization (required no later than 30 days before attending school)
- Snack List Authorization Form (required no later than 30 days before attending school)
- Other forms may be required based on medical conditions

FEES

Registration Fee: A \$75.00 per child and \$40 per sibling **non-refundable** fee is due at the time of registration. Program space is limited and this will hold a space for your child.

School Supply Fee: School supplies or \$40 in lieu of are required for each child. The school supply list will be posted on the website. School supplies or fee will be due on the designated school supply drop off day scheduled in August.

Curriculum Activity Book Fee: For all classes, there is a fee of \$16 per child to cover the cost of the Learning without Tears Curriculum activity books used throughout the year. This fee will be applied to the invoice for the first month of tuition.
